## ACTIVITY GUIDELINES

1. The guest will obtain signature from their home school. The PRHS student will complete the guest pass and return it with a copy of a photo ID to the Safety Office for final signature.
2. Guest Pass **must be** signed by a PRHS administrator before tickets to activity may be purchased.
3. Last day to turn in Guest Pass to Safety Office is seven days prior to event. Must allow 48 hours to process and be returned.
4. In addition to a copy of guest photo ID being required for approval, guest must also present school ID, driver's license, or California ID at the event.
5. Inappropriate dancing will not be allowed. The first offense will result in a verbal warning. The second offense will result in the student and guest being sent home.

## IF THE CHECK-IN AT THE DOOR IS NOT VALID, THE COUPLE WILL NOT BE ADMITTED.

Any violation of school rules, the PRHS student's parents will be contacted to pick up the PRHS student and guest. The PRHS student, upon return to school, will be subject to school discipline. The other student's home school will be notified and guest may be subject to school discipline.
